One half (½) of the initiation must accompany this application. Newington Residents are entitled to a 25% discount on any initiation fees and dues from their date of acceptance to membership.

I UNDERSTAND Indian Hill Country Club dues represent either twelve (12) or twenty-four (24) month commitment depending on initiation fee selected, unless the \$2,500 no commitment initiation fee was selected. During the 12 month or 24 month commitments, resignations before the end of the commitment do not eliminate or reduce the obligation of payment. Invoices will be mailed monthly and payment shall be due on the 20th of each month. Any unpaid invoice balance over 30 days shall incur a penalty designated by the Board of Directors and the By-Laws at that time. In the event that the Club has to use the service of an attorney to collect any outstanding amounts due it, you hereby agree to pay attorney's fees incurred plus the costs of brining a lawsuit. I further understand that, while not anticipated, it may be necessary for the Board of Directors to determine the need for special assessments. If accepted to membership, I agree to pay all such assessments. I agree to abide by all rules and regulations enacted by the Board of Directors.

Membership is contingent upon approval by the Club, which approval shall be at its discretion. I acknowledge that I have received a copy of the Indian Hill Country Club By-Laws which pertains to membership. I have read and understand these By-Laws.
